What Is An Endowment?

An endowment is a fund created to support a cause. The endowment then lives on providing assistance in perpetuity. The donations made to the endowment are reasonably invested and only the earnings on your gift are used to benefit the endowment's purpose. By protecting your gift in this way your contribution continues to give for many generations.

What are the Benefits?

The primary benefit is the satisfaction of providing compassionate care to members of the community. This may include members of your own family, who require end of life care. You also receive a charitable deduction for your contribution and, if you give appreciated assets owned more than one year, you avoid tax on the capital gain.

How Will My Gift Be Used?

Your gift will be added to the Hospice Endowment, and the income generated will be used to sustain hospice care by providing patient care assistance, hospice volunteer and employee training and special equipment for end of life care. Should you choose, it is possible to establish a special memorial for your family within the structure of this endowment. The memorial you establish could also be marked for a special need for hospice. Others who share your interest can also add to the fund for this same purpose.

How Can I Make a Gift?

You can make an outright gift of cash, securities, real estate or you can include a bequest in your will.

Who Will Administer the Endowment?

Mercy Foundation, Inc. will administer the Hospice Endowment. Since its creation in 1973, Mercy Foundation has developed strong community partnerships to financially assist Mercy Medical Center in its vision to improve the health, well-being, and quality of life for families and children. Foundation funding helps develop programs, technology, and facilities, allowing the organization to grow in its ability to enrich the lives of Douglas County residents today and well into the future.
